## 5 MATTERS REFERRED TO THE COURT

In 2023, there was no trade dispute submitted to the Court for arbitration.

## 6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

469 Collective Agreements ("CAs") were filed with the Court in 2023, an increase of 10 CAs over the previous year. Together with the 57 CAs brought forward from 2022, a total of 526 CAs had to be processed and certified. Out of these CAs, 445 were certified by the Court and 7 of them involved public sector employees. At the end of 2023, there were 81 CAs pending certification.

## 7 SETTING ASIDE AND VARIATION OF COLLECTIVE AGREEMENTS

In 2023, 29 setting aside and variations of CAs were filed with the Court compared to 14 applications in 2022. 22 applications were approved, two were withdrawn and five are still outstanding.

## 9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 469 CAs filed with the Court in 2023, 345 CAs had a duration of three years, 112 had a duration of two years and 12 had a duration of between two and three years.
